Request for Certificate of Tax Residency

IRD Form: RCTR02

Purpose

This form is to be used when a request for a Certificate of Tax Residency is made to the Office of the Commissioner for Revenue. It may only be used in connection with taxpayers that are individuals.

1. Accompanying Documents

This form is to be accompanied by such supporting documentation which would support the relevant request.

2. Relevance of Submission of Tax Returns

A valid request for a Certificate of Tax Residency may not be made unless all tax returns that are due, if any, at the time of submission of this form in relation to the relevant individual have been submitted by the date of the request.

3. Signature

Name

This form needs to be signed by the individual making the request or by another person that is authorised to represent the said individual. IMPORTANT: evidence of such authorisation needs to be attached to this form.

4. Where to File

The completed form is to be submitted to the Expatriates Section (Office of the Commissioner for Revenue).
